A \$ _____ deposit is due to bind the terms of this contract. All deposits received are non-refundable.

The balance of \$ _____ will be due on _____ prior to the engagement described herein.

Note: Services requested that exceed the quoted time frame will be charged at the rate of \$150 per hour payable the day of the engagement. It may not always be possible to provide additional performance time.

However, when feasible, requests for extended playing time will be accommodated.

Terms of Agreement

Purchaser shall provide *DJ Mass Appeal* safe and appropriate working conditions. This includes at minimum a 6-foot by 6-foot area for setup and space for setting up speakers (if applicable). *DJ Mass Appeal* requires a minimum of one 15-20-amp circuit outlet from a reliable power source within 50 feet (along the wall) of the set-up area. This circuit must be free of all other connected loads. Any delay in the performance or damage to DJ's equipment due to improper power is the responsibility of the Purchaser. Two circuits are preferred whenever possible. Purchaser is responsible for paying any charges imposed by the venue. These charges may include, but are not limited to, parking and the use of electric power.

This agreement guarantees that *DJ Mass Appeal* will be ready to perform at the start time of the engagement. No guarantee is made as to *DJ Mass Appeal's* time of arrival; however, *DJ Mass Appeal* requests that he is permitted 1 hour before the engagement and 1 hour after the engagement for setup and takedown. If the venue requires setup or takedown in less time additional labor will be charged at the rate of \$50.00 per hour. If Purchaser or venue requires *DJ Mass Appeal* to complete setup more than one hour before the start time or to postpone takedown more than an hour after the end time indicated, the additional time will be charged at the rate of \$50.00 per hour.

It is understood that this is a "Rain or Shine" event, *DJ Mass Appeal's* compensation is in no way affected by inclement weather. For outdoor performances, Purchaser shall provide overhead shelter for setup area. The DJ reserves the right, in good faith, to stop or cancel the performance should the weather pose a potential danger to him, the equipment, or audience. Every effort will be made to continue the performance. However, safety is paramount in all decisions. The DJ's compensation will not be affected by such cancellation.

In the event of circumstances deemed to present a threat or implied threat of injury or harm to *DJ Mass Appeal* or any equipment in *DJ Mass Appeal's* possession, *DJ Mass Appeal* reserves the right to cease performance. If the Purchaser can resolve the threatening situation in a reasonable amount of time (maximum of 15 minutes); *DJ Mass Appeal* shall resume performance in accordance with the original terms of this agreement. Purchaser shall be responsible for payment in full, regardless of whether the situation is resolved or whether *DJ Mass Appeal* resumes performance.

It is hereby further agreed; that the Purchaser shall be held liable for any injury or damages to the DJ, or property of the DJ, while on the premises of said engagement, if damage is caused by Purchaser or guest, members of his organization, engagement invitees, employees, or any other party in attendance, whether invited or not.

A written event/music planner or music request list must be received from the Purchaser and forwarded to *DJ Mass Appeal* at least two weeks prior to the date of the engagement for it to be included in *DJ Mass Appeal's* programming guidelines. With or without the aid of an event/music planner or music request list, *DJ Mass Appeal* shall attempt to play Purchaser's and Purchaser's guests' music requests but shall not be held responsible if certain selections are unavailable.

In the event that *DJ Mass Appeal* becomes unable to provide his services due to complications beyond his control, a reputable replacement shall be provided at no more than the original price agreed on in this contract.

The parties purchasing the services of *DJ Mass Appeal* agree to allow *DJ Mass Appeal* to use pictures and video images taken at this event for promotional purposes.

In the event of non-payment, *DJ Mass Appeal* retains the right to attempt collection through the courts. Purchaser will be held responsible for all court fees, legal fees, and collection costs incurred by *DJ Mass Appeal*. Additionally, Purchaser shall be charged \$25 for each returned check. In an event that the client has paid for time not used, a refund of said time will be processed 7-10 days from the end of event.

This agreement is not binding until signed by the Purchaser and *DJ Mass Appeal* has received and executed it. Any changes must be written and signed by both the Purchaser and *DJ Mass Appeal*. Oral agreements are non-binding. If any clause in this agreement is found to be illegal, the rest of the agreement shall remain in force.

I understand the terms and conditions described herein, and will abide by them.

By executing this contract as Purchaser, the person executing said contract, either individually, or as an agent or representative, represents and warrants that he or she is eighteen (18) years of age, and further, if executing said contract as agent or representative, that he or she has the authority to enter this agreement and should he or she not have such authority, he or she personally accepts and assumes full responsibility and liability under the terms of this contract.
